- It would be very unlikely to get a lower speed limit enforced on Clay Street and Field View, but a metric count would provide evidence of vehicle speeds as a starting point.

The income received was £185.07 Proposed: Cllr Cameron; seconded Cllr S Orchard Receipts & Payments to 27 June 2022 was noted. The year-to-date surplus is £1781 22/07/5.2 The bank balances stand at £20879.40 to end June 2022. The bank reconciliation for June was signed by the Chair. 22/07/5.3 The Councillors considered the current allotment rental agreement and decided that no amendments were required, except for the wording clean to be changed to clear (point2). It was decided to keep the rent at £20 for a further year. Proposed Cllr Minshell; Seconded Cllr S Orchard Following the allotment inspection and holders meeting it was requested that the clerk write to the two allotment holders whose plots have not been cultivated this season. Action: Clerk Network Rail to be contacted regarding bramble encroachment. Action: Clerk The mowing regime will be reviewed for 2023 to take account of comments regarding grass along cemetery boundary fence. The Council are following a specific long-term plan with regard to biodiversity and wildflower management. The Councillors considered the comments regarding security and potential theft of produce. It was decided that no action should be taken at present as the threat was minimal, allotment holders are asked to monitor any trespass onto their allotments and report any issues of this nature to with the Clerk. The Councillors are keen to encourage LS residents to visit the Community Orchard but remind the public that individual allotment plots are not for public access. The list of current licence holders was noted; it was requested that the allotment agreements be sent out in September.
